FACILITIES: To provide the best possible magical experience, it is understood that David needs a **performance area at least 12 feet wide and 8 feet deep**, which is **raised** at least 1 foot for every 100 people in attendance (e.g. floor level for 75 people, 2 ft for 225 people, 4 ft for 400 people). You will also be responsible for providing **110 volt AC grounded electricity** to within 5 feet of the performance area. This area needs to be in front of a **neutral background** (usually a solid wall with no backlight, windows, mirrors, doorways or other distractions). Otherwise, some of the most powerful magic will be limited. If a meal is being served in the same area, it is understood that **TABLES WILL BE CLEARED** before the performance starts.

ARRIVAL, LOADING & DEPARTURE: David will arrive 90-120 minutes before the performance. Please have someone there to assist with unloading equipment before and reloading it after the performance. David is usually driving away 60 minutes following the performance.

PRIVACY: It is understood that in order to provide a mystifying experience of wonder, David will need **secured privacy** for setting up his show without being interrupted. He also needs a secure place to store packing cases.

RECORDING: It is understood that there will be **no video recording** of the performance without his permission.

TAX WITHHOLDING: It is also understood that David Reed-Brown is hired as an **independent contractor** and not as an employee. As an independent contractor, he assumes all responsibility for withholding tax and social security.

CANCELLATION of this agreement or any **CHANGES** to the scheduled date and time must be agreed on by both parties.

KILL FEES: Please note that canceling performance within seven days requires 50% payment. Canceling the day of performance requires 100% payment.

TO SIGNIFY AGREEMENT, please sign below, make a copy for yourself, and **return this original with a 20% deposit within one week** to reserve the date and time. The balance of the fee will be due the day of performance. Thank you.
